PENNSYLVANIA'S LITTERING LAW - Section 3709 of the Vehicle Code provides for a fine of up to \$300 for dropping, throwing or depositing, upon any highway, or upon any other public or private property without the consent of the owner thereof or into or on the waters of this Commonwealth from a vehicle, any waste paper, aweepings, ashes, household waste, glass, metal, refuse or rubbish or any dangerous or detrimental substance, or permitting any of the presenteding without immediately removing such tiems or causing their removal. For any violation of Section 3709, it may be subject to a fine of up to \$300 upon conviction, including any violation results from the conduct of any other persons operating, in possession of or present within this vehicle with my permission, if I do not with reasonable certainty identity the driver of the vehicle at the time the violation occurred.
